Mr. Chwen-Wen CHEN graduated from National Taiwan University and received his Master of Laws and his Doctor of Juridical Science degree from the University of Paris II (Panthéon-Assas). He was an Assistant Professor of Law at the Law School of the Chinese Culture University in Taipei and then worked as Assistant Research Fellow at the jurisprudential section of Sun Yat-Sen Institute For Social Sciences and Philosophy, Academia Sinica, the equivalent of the US Academy of Sciences in Taiwan. He is now professor of Public Law at the Department of Political Science and Graduate Institute of Public Affairs, National Taiwan University, and Senior Research Fellow at the Institutum Iurisprudentiae, Academia Sinica.

Since 1999, he has taught the Constitutional Law, the Administrative Law, the Introduction of Law, Seminar on Public Law, Seminar on EU integration, Seminar on EU Law, Seminar on the French Public Law and Seminar on the Media Law at both graduate and postgraduate degree. He has served as legal consultant or commissioner at various government agencies, including the Law and Regulation Commission of the Cabinet, the Law and Regulation Commission of the Ministry of Justice and the Law and Regulation Commission of Taipei City Government. He is now Director of Graduate Institute of Public Affairs and Deputy Director General of European Union Center in Taiwan.

Specialized in constitutional law, administrative law, French public law and European law, he focuses his research on the comparative public law. In these fields, he has a rich bibliography in books, journals and articles published largely in Chinese.
